TRAI has directed to ensure that the Reporting shall also contain Name, Designation and contact number of the authorized reporting officer/signatory for future reference. However, the circles should not endorse/send this circular for tariff reporting purpose and the content of the tariff should only be reported for tariff reporting.
- 5. This may be brought to the notice of all concerned for taking necessary action in this Regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
- 6. This circular is issued based on the approval of ECT vide Approval No.3238 dated 12.02.2018 in P&P-CM cell file No.3-38/ECT/2015/P&P-CM (Pt.II).
