- 1. The Circles to be merged/tagged are requested to complete all the month end activities on or before 30.11.2020.
- 2. The CSC of ETP will stop functioning from 01.12.2020 and all the operation bank accounts will continue to be operated till three months from the said date and thereafter the accounts have to be closed.

3. All Circles/BAs going to be merged/ tagged should ensure that no cross BA GR/IR is pending for completion. The entire cross BA POs have to be short closed or the required necessary activities have to be completed on or before 30.11.2020.

- 4. All the workflow items should be completed on or before 30.11.2020 in respect of all circles/BAs going to be merged/ tagged.
- 5. The Intra-circle remittances have to be eliminated and Inter Circle Remittances have to be reclassified/ regrouped. Suppose ETP Patna has any remittance balance against ETR circle, the same have to be reclassified as going forward it will be part of ETR.
- 6. Clearing should be mandatorily done otherwise balances will go haywire and will be difficult to reconcile.
- 7. The GST will have to be dealt as per the extant guidelines as no change will be involved in GST.
- CAPEX Budget available at circles IM node should be distributed to the respective BAs IM nodes by circles (ETP & ETR) which are going to be tagged. Budget remained at circle IM node will get lapsed on 01.12.2020.
- 9. The Circles in which the Circle/BAs will be merged/tagged should ensure that from 01.12.2020 the Financial Statements are generated after grouping/including the merged BAs also.
- 10. The new Circle codes will appear in the documents of tagged BAs from the effective date of tagging, whereas old documents continue to appear the Circle code (Old Company Code) in posted documents.
- 11. All the PGI & its Invoice have to be done by the user of respective unit before start of merger activity.
- 12. All the sales invoices which have not been released to accounting have to be cleared on or before 30.11.2020.
- 13. In next phase the tagged BAs TBL will be migrated and the BA will get ceased.
