

Sub:- Extending the benefit of ACP on upgraded scale to the Executive cadres of Civil/Architect/Electrical/Telecom Factory and CSS/CSSS etc. who had earlier opted for EPP and could not exercise option i.r.t. Order No.15-70/2007-Pers.II dated 20.05.2010 & 24.05.2010 – regarding.

Sir,

Kindly refer to this office Order No.15-70/2007-Pers.II dated 20.05.2010 & 24.05.2010, wherein as per recommendation of the Nagpal Committee, ACP benefits on upgraded scales was granted to the Executive cadres of Civil/Architect/electrical/Telecom Factory and CSS/CSSS etc. and options under para 1(I)(d)(7) was called for from the executives who had earlier opted for ACP scheme to avail upgradation during 1.10.2000 to 1.10.2004 on non-upgraded/Government scale. This option was not extended to those who had opted for EPP earlier.

Recently, some cases have been referred by Circles to this office seeking clarification as to whether those executives who opted for EPP and not ACP (as ACP was then not available on upgraded scales i.e. between 20.8.2007 to 21.04.2009) can be considered for giving option retrospectively as has been done in case of ACP optees as per Nagpal Committee.

The issue raised is accordingly being examined, for which relevant input/data with regard to the number of such executives in various cadres who opted for EPP and the financial implication involved in case option is granted to them afresh need to be worked out by the respective staff branch/cadre controlling authorities.

It is therefore, requested to send the above cited requisite input/data at the earliest, preferably within a week, so that the matter is settled at the earliest as desired by the Competent Authority.
