I am directed to refer to this office letter No. 15-70/2007-Pers.II dated 21.4.2009 by which the benefit of ACP on upgraded scales was restored in respect of PA/PS of field formation in supersession of earlier instruction on the subject contained in letter No. 25-4/2006-Pers.II dated 20.8.2007. For considering grant of similar benefit to the Executive cadres of Civil/Architect/Electrical/Telecom Factory and CSS/CSSS etc., the BSNL Management constituted a Committee, who considered the various issues involved in detail and recommended for adopting uniform approach and granting similar treatment to the Executives of left out cadres who were not covered earlier in the letter/order dated 21.4.2009.

Further, the Committee also recommended that as an one time measure, the Executives, who had earlier opted for ACP scheme to avail upgradation during 1.10.2000 to 1.10.2004 on non-upgraded/Government scale [in response to BSNL Executives Time Bound/Post Based Promotional Policy for Executives vide letter No. 400-61/2004-Pers.I/308 dated 18.1.2007 as per para 1(d)(7)] and are now willing to change their option may be permitted to do so within one month of issue of order based on the recommendations of the Committee.

After due consideration and detailed examination of the recommendations made by the Committee, it has been decided by the competent authority that the order No. 25-4/2006-Pers.II dated 20.8.2007 be treated as withdrawn in respect of Executive cadres of Civil/Architect/Electrical/Telecom. Factory and CSS/CSSS etc. as well. Accordingly, the grant of financial upgradation under the ACP scheme as envisaged in this office letter No. 25-05/2005-Pers.II dated 12.9.2005 may be made applicable to these cadres also.
