

- 2.0 The Executives from Sr. No 1 to 6 have been promoted against vacancy year 2011-12 and from Sr. No 7 to 24 against vacancy year 2012-13.
- 3.0 The Posting of Executive(s) to the sensitive/ non-sensitive posts shall be done as per the prescribed norms circulated by the DOT / Vigilance Cell BSNL CO from time to time.
- 4.0 The Executives shall be relieved immediately as per specific posting orders.
- 5.0 The promotion shall be effective from the date of assumption of charge of the post of SDE (E).
- 6.0 The above promotion order is issued after obtaining the vigilance clearance from the vigilance branch of concerned circles. However, in case it comes to the notice of the Controlling Authority that disciplinary proceedings has been initiated / pending or any punishment of stoppage of increment etc. is in operation against the executive, the executive shall not be relieved/ allowed to join the place of posting on promotion

without obtaining the specific approval of this office. All such cases may be forwarded to this office within 15 days from the date of issuance of this order for taking appropriate action.

- 7.0 The PCEs(E)/Sr.CEs(E)/ CEs(E) concerned shall take appropriate action regarding relieving / posting etc. of the Executives so as to enable them to join the assigned place of posting at the earliest.
- 8.0 In case, the Executive(s) concerned fail to join with-in the prescribed time period of 40 (forty) days i.e upto 17.06.2014, the executive(s) shall not be allowed to join the post(s) thereafter. In such an event his/ their promotion order(s) shall become inoperative and the matter shall be reported to this office for further necessary action.
- 9.0 The leave, if any requested by the executive, under promotion / transfer, shall not be granted by the controlling officer where they are presently working.
- 10.0 The above promotions shall be subject to the outcome of court case(s), if any, pending before the Hon'ble Court(s)/ Tribunal(s).
- 11.0 The posting of executive at Sr. 11 is request posting and therefore, no transfer benefits shall be admissible.
- 12.0 The charge report may be furnished to all concerned.
- 13.0 The pay will be fixed as contemplated in BSNL Employees Promotion Policy circulated vide No 400-61/2004-Pers.I dated 18th Jan. 2007 and amendment thereof.
- 14.0 This is issued with the approval of the Competent Authority.
