6.0 In case, the Executive(s) concerned fail to join with-in the prescribed time period of 40 (forty) days, the executive(s) shall not be allowed to join the post(s) thereafter. In such an event his/ their promotion order(s) shall become inoperative and the matter shall be reported to this office for further necessary action.

7.0 The leave, if any requested by the executive, shall be allowed only after joining the new assignment.

8.0 The above promotions are subject to the outcome of court case(s), if any pending before the Hon'ble Court(s).

9.0 Pay of the Executives shall be fixed as per BSNL MS RRs 2009.

10.0 The Posts of SE(Elect) Jodhpur & SE(Elect) Jabalpur stand diverted as DGM (Elect-Ext Project), BSNL CO, New Delhi and DGM (BS-E), RTTC, Nagpur respectively till 31.05.2014. These posts shall automatically stand re-diverted without any further orders on vacation of the post (s) by the executive (s) on their superannuation.

13.0 The posting of executive at S.No 4 is at "Own Cost" & hence the executive shall not be entitled for transfer benefits etc.


