3. The executives who are transferred above, in case, are looking after in a higher grade locally, the arrangements should be terminated before relieving them.



In view of acute shortage of executives of Telecom Finance in the grade of AO/ Sr.AO in the circles where they have been transferred, their request could not be acceded to due to administrative exigencies, Hence the Circle IFA(s) are requested to relieve the executive(s) under transfer not later than **22.08.2014** and TA/TP may be regulated as per the guidelines issued by BSNL vide letter No: 19-27/2002-L&A(Part) dated 15.04.2004, OM No.412-10/2009 Pers I dated 09.05.2012 and on the basis of further orders issued on the subject from time to time.
