Subject:- Holding of Limited Internal Competitive Examination (LICE) for promotion to the grade of Junior Telecom Officer (Telecom) {JTO (T)} in BSNL.

Sir.

Kindly refer to this Office letter of even no. dated 28/01/2016, on the above mentioned subject. As mentioned at para 3 of the aforesaid letter, a model notification for holding the Limited Internal Competitive Examination (LICE) for promotion from Group 'C' employees to the grade of Junior Telecom Officer (Telecom) {JTO (T)} in BSNL to be issued by the Circles is enclosed herewith. However, in partial modification to this Office letter of even no. dated 28/01/2016, it has been decided with the approval of the Competent Authority that the aforesaid LICE is to be held for the vacancy year 2013-14 only in view of the Court verdict. Accordingly, the Circles are requested to calculate the vacancies as under:

- Total no. of posts of JTO (T) under 50% Internal Quota in the Circle for the vacancy i) year 2013-14, without counting the no. of officials absorbed through absorption process, as per JTO (T) Recruitment Rules-2014 in the Circle, which is to be taken into account against the vacancy year 2015-16 onwards;
- Category-wise vacancy position (OC, SC, ST) for the vacancy year 2013-14. ii)
- All the Telecom Circles are required to prepare the notification as per the model notification in respect of their Circles, after calculating the vacancy positions in respect of their Circle. The notification is to be issued by all the Circles on 04/03/2016.
- The Circles must strictly adhere to the time schedule mentioned for the aforesaid 3. LICE.
- The receipt of this letter may please be acknowledged and the Circles must furnish a copy of their notification issued for the aforesaid LICE to the Recruitment Branch of BSNL CO through the e-mail IDs provided vide this Office letter of even no. dated 28/01/2016.
