Sub: Maintenance of services and office discipline in view of agitational programme from 27.06.2018 to 29.06.2018 by SNEA and AIBSNLEA, Associations of BSNL – Regarding.

Please refer to communication under reference of SNEA and AIBSNLEA wherein following agitational programme has been intimated:

- a. SNEA has asked all CS and CHQ office bearers to have a meeting at New Delhi on 27 and 28th till BSNL notifies CPSU cadre hierarchy.
 - b. AIBSNLEA is organising *Central Office Bearers, Advisors, Consultants and Circle Secretaries meeting at New Delhi on 28th and 29th June 2018 to discuss the status for holding of all the CPCs in all the disciplines to fill-up all vacant Group "B" and Group "A" level posts in various disciplines before notification of CPSU Cadre Hierarchy.* And has served a notice for demonstration on 27.06.2018.
2. As all are aware that Management has time and again been issuing advisories/ appeals to the Unions/ Associations not to resort to any agitational programme, inter alia, in view of pending conciliatory proceedings before the RLC. Thus, the above aforesaid agitational programme is in violation of provision of Section 22 of ID Act 1947 and is illegal.

In addition, the Hon'ble Patiala House Court at New Delhi has also passed an interim injunction order "restraining them from further intensifying the ongoing strike so as to impede the functioning of the BSNL...." (conveyed vide this office letter dated 08.05.2017). Despite all the advisories / appeals made by the management, there is no intimation of withdrawal of above said programme on .06.2018.

3. Apart from above, efforts are being made by Management to convince the SNEA and AIBSNLEA Associations to withdraw the above agitation programmes and

issued appeal. However, in order to handle the situation that may arise due to the agitation, it is advised that appropriate action may be taken in accordance with the instructions issued from time to time, which may include :


- a) Non-grant of any kind of leave.
 - b) Cancellation of leave if already granted for the proposed agitation programme. However, in exceptional circumstances, leave applied for can be granted for genuine reasons subject to the personal satisfaction of the leave sanctioning authority and with prior approval of next higher authority. Leave should always be refused i/c permission to leave headquarter when an employee wants it for participating in any such agitation programme. In cases where after obtaining leave on some other pretext an employee participates in any such agitation programme, suitable disciplinary action should be taken against him for dereliction of duty.
 - c) Principle of "No Work No Pay" against those employees who participate in the agitation programme.
4. In view of the above, a compiled status report on the agitation on 27, 28 and 29.06.2018 may be furnished by the Circles/ PGM (Pers) (in respect of Corporate Office units) to the SR Cell, Corporate Office positively everyday as per the prescribed proforma.
