Sub:- Furnishing details of financial implication in case the benefit of ACP on upgraded scale is extended to those Executives who had earlier opted for EPP due to non availability of ACP on upgraded scale even though they being eligible for grant of ACP during the period 1.10.2000 to 30.09.2004 and opted EPP under compulsion because of non-grant of ACP on upgraded scale – Regarding.

It is stated that in case of Steno/PA of BSNL field units the grant of ACP on upgraded scale was withdrawn vide this office order dated 20.08.2007 and was reinstated vide order dated 21.04.2009. Further, this facility was extended to the Executive cadres of Civil/Architect/Electrical/Telecom Factory and CSS/CSSS etc. as per recommendation of the Nagpal Committee and options under para 1(l)(d)(7) was called for from the executives who had earlier opted for ACP scheme to avail upgradation during 1.10.2000 to 1.10.2004 on non-upgraded/Government scale. However, such option in many cadres was not extended to those executives who had earlier opted for EPP on account of non-availability of ACP on upgraded scale.

It has now been proposed to extend the benefit of option of ACP on upgraded scale to those executives of Civil/Architect/Electrical/Telecom Factory and CSS/CSSS etc. who opted for EPP due to non-availability of ACP on upgraded pay scale and have been left by the Nagpal Committee. As such, there may be several other executive cadres where the ACP Scheme was available and executives has opted for EPP instead of ACP during the period 1.10.2000 to 30.09.2004 due to non availability of ACP on upgraded scale.

It is therefore requested to furnish the relevant input/data in the enclosed proforma with regard to the number of such executives i.e., in JTO Cadre/SDE(T) Cadre, if any, who has opted for EPP instead of ACP during the period 1.10.2000 to 1.10.2004 due to non availability of ACP on upgraded scale and the financial implication involved in case option is granted to them afresh. In case no such Executive is available, a "NIL" report may be furnished to this office.

The above said information may be sent to this section at any early date for taking further necessary action in this case.
