With the approval of the Competent Authority, it has been decided to conduct Direct Recruitment of Junior Telecom Officer (Telecom) {JTO (T)}, for the year 2015-16 from open market. The aforesaid Direct Recruitment is to be conducted through Online examination method in a centralized manner by the Recruitment Branch of BSNL Corporate Office through the Examination Agency. The notification for the aforesaid Direct Recruitment is likely to be issued shortly by the Recruitment Branch of BSNL Corporate Office. The proposed vacancies to be filled under Direct Recruitment Quota for the Recruitment Year 2015-16 is enclosed as **Annexure – II**.
