**Subject:** Reservation for Other Backward Classes in Civil posts and services under the Government of India- Sub-quota for Minority Communities.

The undersigned is directed to refer to Department of Telecommunication's OM No. 2-4/2012-SCT, dated 5.3.2013 the above subject and to say that the provision for providing reservation to Minority Communities through 4.5 % sub quota reservation within the 27% reservation for OBC has been quashed by the Hon'ble High Court of Hyderabad (Andhra Pradesh). Though an SLP is admitted in the Supreme Court, no stay against the decision of High Court has been granted by the Hon'ble Supreme Court. *The matter is sub-judice.*
