**OFFICE ORDER**

**Subject: Promotion order issued on dated 30.03.2011 and subsequent orders from time to time of JTOs to the grade of SDE (Telecom) in B.S.N.L. against 67% seniority-cum-fitness quota (Promotion quota).**

The process of implementation of promotion order dt. 30.03.2011 and subsequent orders was stopped vide this office communication vide letter no. 15-26/2011 dated 12.07.2011 and all the Circle Heads were requested that JTOs promoted to SDE(T) grade under the said orders may not be further relieved till further instructions due to the interim injunction imposed on 05.07.2011 in WP No. 16102/2011 and on 15.11.2011 in WP No. 26246/2011 by the Hon'ble High Court of Madras.

2. It has now been intimated that WP Nos. 16102/2011 and 26246/2011 filed by Sh. A Kruba Sankar and AIGETOA respectively stand dismissed by the Hon'ble High Court vide their order dated 02.04.2013. As a result, all the Heads of Telecom Circles are requested to relieve the left out JTOs immediately to join their already assigned circles/posting excluding those who have declined the said promotion, the records of which are available with the circles. In such cases circle concerned should check names of the officers carefully and meticulously before offering further promotion at their end.

3 The JTOs who were posted to Hard Tenure Circles and were not relieved/ relieved but could not join due to court injunction, their circle/posting on promotion has now been modified/changed to soft tenure stations of the same /adjoining circles as per the **Annexure enclosed**. This list includes the names of those JTOs i.r.o whom the joining status has been given by the concerned circles.

4 CGM concerned may accordingly please ensure that the promotion/posting order are issued in accordance with all terms and conditions laid down in the promotion order dated 30.03.2011 and in the stipulated time to enable the officers to join their promotional assignment immediately, and also the officer are relieved within the prescribed time limit of 10 days (including the joining time) from the date of issue of this order without fail.

5. The names of the officers who were included in earlier promotions orders and have since retired from service on account of superannuation/VR etc. and are no longer available for promotion may deemed to have been deleted from the list.

6. The date on which the above order is given effect to may be intimated to this office and a consolidated report of the officers who have been relieved/have joined their assigned postings may also be sent immediately on expiry of 10 days from the date of issue of this order.




