Subject: - Verification of personnel data of Executives in SAP Portal from service book for implementation of e-DPC/CPC through SAP Portal w.e.f 01.04.2021.

It has been decided with the approval of the competent authority to implement e-DPC/CPC Module on ERP platform w.e.f 01.04.2021. All the DPCs/CPCs (EPP, Post based etc.) are planned to be conducted through SAP w.e.f 01.04.2021. For successful implementation of e-DPC/CPC Module, the following two works are to be completed on priority basis latest by 28.02.2021.

- 1. Verification of employee data in SAP Portal from service book.
- 2. Feeding of Manual APAR data into ERP system for the period from 2014-15 to 2016-17/2017-18.

For verification of personnel data, T Code "ZHR_PROMO_INFO" is being developed, under which all relevant fields required for promotion/Upgradation have been incorporated. The code has been designed to facilitate the personnel data updation at SSA/Circle/ BSNL CO Levels.

Further, for uploading of manual APAR data T code "ZHR_APAR_Offline" is being developed in ERP. The past years Manual APAR from 2014-15 to 2015-16 for all executives and Manual APARs for period 2014-15 to 2016-17 in respect of PA/PS /Dual reporting structure are to be uploaded in the ERP portal through above mentioned T code. Online APAR system was introduced from 2016-17, however some executives have submitted manual Part period APAR for year 2016-17 and the same is also required to be uploaded in ERP. Both above mentioned T codes will be made operational w.e.f 08.02.2021.

Further, scanned copy of these Manual APARs may be shown to the DPCs/CPCs at the time of holding of DPC/CPC. T- Code is being developed to upload these scanned APAR copy in ERP also.

Accordingly, the Circles Heads/GM (HR) are requested to ensure that above works are completed by 28.02.2021.

Further, certificate duly signed by the GM (HR) of circle office regarding complete verification/updation of personnel data and past years manual APAR data may be submitted to this office latest by 5th March 2021 without fail.
