ad-hoc basis - calling of ACRs and Screening Committee report regarding.



The undersigned is directed to state that as per the decision of the competent authority, Preparatory work has to be done for the promotion of Executives (TES Group B) to AGM/DE(Ad-hoc) basis . The Executives falling in the zone of consideration for this purpose are to be considered for the ensuing CPC. Along with the above ref. letter, a list of eligible TES Group B officers has been put on intranet on 12 the August 2011 for sending the ACR for the reckoning period of 06-07 to 10-11 with screening committee report.

But from your circle, in some cases ACRs were sent only for 09-10& 10-11 saying that the remaining ACRs for the years 06-07 to 08-09 are with AGM DPC. But as per DPC records, the ACRs of the officers considered in the previous CPC from STR (106 nos, 91+15(SC) were sent back with Sri. C.K.Ganesh, SDE(T),O/o CGM STR, Chennai on 07-04 -2011. Hence it is reiterated that the remaining ACRs of the officers in Annexure attached with (marked as \*\*\*) should be sent immediately to complete the preparatory work.
