Revised Provisional Seniority Lists 6 & 7 of TES' Group B equivalent to SDE(T) - Implementation of judgment dated 25.8.2009 of Hon'ble CAT, Chandigarh Bench in TA No. 84/HR/2009 etc. - regarding

Provisional seniority lists 6 & 7of \$SDE(T) were circulated vide office letter of even number dated 1.4.2015 in compliance of Hon'ble CAT, Chandigarh, order dated 25.8.2009 in TA No. 84/2009. A submission has been made before the Hon'ble CAT, Chandigarh Bench to mention the date of joining of the SDEs(T) in the aforesaid lists so as to facilitate verification about the correctness of the placement in the seniority.

- 2. The promotion of SDEs(T) placed in seniority lists 6 & 7 were primarily made by two main orders vide DoT letters No. 3-75/2000-STG-IV dated 26.4.2000 and order No. 2-82/2000-STG-II dated 7.12.2001. As per the order dated 21.6.2011 of Hon'ble High Court of Bombay, the date of promotion order viz 7.12.2001 has been taken as the date of joining. The Hon'ble Supreme Court has also upheld the view of the High Court Order vide its order dated 12.8.2014 in SLP (C) No(s) 35756/2012 arising out of impugned final order dated 21.6.2011 in WP No. 3725/2011.
- In the provisional seniority lists 6 & 7 dated 01.04.2015, names of SDEs(T) promoted as per the DPC held in June, 2002/February-2003/August-2003 against later vacancy year have been placed above the 124 CQ SDEs(T) who have been granted notional promotion w.e.f 23.1.2002. The seniority of the 124 CQ officers have now been placed enbloc above them.
- 4. Based on the above facts, date of joining has been mentioned against the names of individual SDEs(T). Accordingly, revised provisional seniority lists 6 & 7 are enclosed in Annexure I, I(a), I(b) and Annexure II, II(a), (b) respectively.
- 5. Errors in name/category/HRMS and omissions in the revised provisional seniority lists 6 & 7 may be brought to notice by 9th May, 2015. Errors in DOB may be ignored.
