Subject: Reconciliation of inter-se seniority of some SDEs(T) belonging to ST category promoted to the grade against VY 2001-02 vis-a-vis their gradation details – regarding

On the basis of the information received from Circle offices concerned, AIEL dated 13th November, 2001 and minutes of DPC, the relative seniority of ST Officers in seniority list 7 has been re-arranged against eligible vacancy year in the following order and manner.

(i) Recruitment Year,

(ii) Training attempt.

(iii) Training Marks

(iv) Senior ST Officers with 2 - 3 years qualifying service have been re-assigned seniority with reference to the junior having 3 years' service and with respect to the vacancy year assigned to such junior. Thus, along with the revision of their seniority, their vacancy year has been changed from 2001-02 to 2000-01 or 1999-00, as the case may be.

2. Some of the Executive do not fulfil the requisite eligibility conditions of 3 years qualifying service by general standard or 2-3 years' qualifying service by relaxed standard with reference to a junior having 3 year's general qualifying service. The seniority of such of the ST Officers has accordingly been revised and is placed in vacancy year 2000-01 or 2001-02, as the case may be.

4. The revision of seniority is only in respect of those ST Officers who have been promoted as SDE (T) on the basis of RR, 1996 and whose names are in revised final seniority list 7 dated 8.6.2015. The revision in seniority has been made with reference to the representations received from several Executives and is accordingly revised for the purpose of seniority only.

5. The names of retired ST Officers etc. have not been considered for revision.

6. A list showing the pre-revised and revised seniority of these ST Officers is enclosed in Annexure I.
