Subject:-Restructuring and re-distribution of Hindi Cadre Posts in BSNL – Regarding.

Sir,

The Management Committee of BSNL Board has approved restructuring and re-distribution of Hindi Cadre posts in BSNL, whereby, the following decisions have been taken:

a) Hindi Cadre posts of BSNL has been restructured and the number of posts of different grades of Hindi cadre post has been re-distributed taking into consideration the different aspects of a Circle viz., Size of the Circle/PGMTD/SSA vis-a-vis the Hindi language used in correspondence etc.

b) In lieu of upgradation of pay scale of Rajbhasha Adhikari from E-1 to E-2, 37 posts of the Rajbhasha Adhikari have been abolished. The abolition of 37 posts have been considered on saving basis to have no financial implication on account of this scale upgradation. However, out of the 37 posts which are to be abolished, some regular Rajbhasha Adhikari incumbents may still exist in addition to vacant posts, hence they shall still continue on the post till their retirement and the respective posts shall be automatically abolished after their retirement.

c) Rajbhasha Adhikari has been re-designated as SDE(OL).

d) On upgradation of scale of Rajbhasha Adhikari from E-1 to E-2 scale, a gap has been created at E-1 level, hence in order to bridge the gap between Sr. Hindi Translators in NE-10 Scale and Rajbhasha Adhikari at E-2 scale, a separate Hindi Cadre post, designated as JTO(OL) at E-1 level similar to that of other cadres viz., JTO/JAO/AM has been created.

e) 117 posts of JTO(OL) have been created on matching saving basis, whereby 142 posts of Junior Hindi Translators (JHT) have been surrendered/abolished to match financial implication.

f) The newly created JTO(OL) cadre shall be filled up by 50% through Limited Internal Competitive Examination (LICE) from amongst Junior Hindi Translators with 7 years regular service in the grade and Senior Hindi Translators with 5 years regular service in the grade. Remaining 50% of the posts shall be filled through Direct Recruitment as it will provide young talent directly from the open market to meet future needs of the Organization.

g) The Recruitment Rules/Scheme & Syllabus/ Duties & Responsibilities of JTO(OL) cadre shall be issued separately by Establishment Branch of BSNL C.O. in consultation with OL Section of BSNL C.O.

h)The Restructured Hindi Cadre shall be as under. Circle wise details are indicated in the Annexure. As the Hindi Cadre is a circle cadre post, the CGM of the concerned circle is authorised to make relocation of various posts among different SSA & Circle Office in their Circle under specific requirement and justification.
