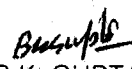

In continuation to this the, BB Cell has informed vide letter under reference(iii), that the nomenclature of Type-I and Type-II CPEs, being procured as part of 8 Mn CPE Tender, under reference, has been changed. New nomenclature of CPEs is as follows:

2. In addition to this, MRP of these CPEs is now fixed and is as follows:

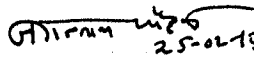
Type	MRP
