Subject: Review of tariffs of 1Gbps Internet Leased Line (ILL) services of BSNL - regarding

The tariffs and other terms and conditions of Internet Leased Line (ILL) services of BSNL (for 1:1, 1:2 and 1:4) were issued vide this office letter no. 111-3/2004-comml. dated 01.3.2004, 10.02.2005 and 30.3.2011 and further the same was revised vide letter no. 111-3/2004-comml. dated 20.9.2004, 30.9.2004, 30.11.2005, 04.05.2006, 27.11.2006, 15.01.2008, 08.01.2010 and vide letter no. 112-5/2010-BP-Ent dated 29.3.2012.

2. Tariff of 1 Gbps ILL was issued vide letter no. 111-3/2004-comml. dated 30.3.2011.

3. After revision of ILL tariff up to 155 Mbps vide letter of even no. dated 29.3.2012, it has been decided by the competent authority to revise the tariff of 1Gbps (for 1:1, 1:2 and 1:4) ILL as under:

4. Other terms and conditions :

(i) There would not be any difference in tariff for ISP and Non-ISP categories.

(ii) The discount, **including discount to educational Institutions and loyalty discount**, already provided to the existing/new customers will not be applicable on the new tariff. However, customers will migrate to the revised tariff after the expiry of the commitment period. The circles will have to revise the discount on the new tariff to the existing customers.

(iii) Local lead charges shall be applicable in MTNL area on back to back payment basis.

(iv) The above charges also include local lead charges if local lead is provided on existing media within the local telephone system area. If the customer is not located in the local telephone system area, 50% discount on local lead charges will be applicable.

(v) All the terms and conditions will remain same as mentioned in letter no. 112-21/2009-BP-Ent dated 21-12-2009, 29-7-2010, 14-2-2011, 29-9-2011 and 29.3.2012 and letter no. 112-5/2010-BP-Ent dated 29.3.2012.

(vi) The discounting powers of Head of circle and GM(EB-City)/ GM(EB-Circle) and ECT-EBU of BSNL CO will remain same as issued vide this office letter of even no. dated 30.03.2012.

(vii) The above mentioned tariff is applicable **w.e.f. 01.04.2012.**
