Sub: Revision of tariff for Bulk push SMS service –reg.

Kindly refer to order No.200-25/2009-VAS dated 25.03.2009 and this office order of even No. dated 11.01.2013, 24.01.2013, 04.06.2013, 02.08.2013, 31.01.2014, 03.02.2014 and orders/clarifications issued from time to time on the subject mentioned above. Now based on feedback received from field units it has been decided by the Competent Authority to revise/ modify the tariff/slabs of Bulk Push SMS as under:-

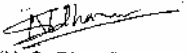
ii) Total discounting power of 2 paisa has been modified as mentioned above.

3. This may be brought to the notice of all concerned for taking necessary action in this regard.

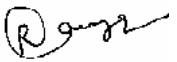
