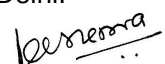
a) Start-up Kit:

- ii) USIM & Activation- Rs.59

b) Plan Voucher:

Particulars	Revised Tariff
MRP (inclusive of S. Tax)	Rs.60
Free data usage	1GB with a validity of 30 days
Plan Validity	365 days
Base Tariff	As per Prepaid General

- 2. All other terms and conditions will remain same.
- 3. The above tariff will be implemented with effect from **11.07.2012**.
