Circular T&C -CM No. 66/11-12

Sub: Introduction of new RUIM based prepaid plan "Parivar" and rationalization of tariff under CDMA services -reg.

It has been decided by the competent authority to introduce a new prepaid RUIM plan "Parivar" and rationalize the tariff of STVs and data usage under CDMA services as under:-

i) All existing postpaid CDMA/GSM/Landline customers are to be offered one RUIM free of cost under new CDMA prepaid "Parivar Plan" with the following terms and conditions:-

- The tariff plan charges is inclusive of Service Tax @10.30%. Circles can suitably adjust the price band upto Rs.3 (+/-) of above price considering the local market condition and technical feasibility.
- In case of Assam, J&K and North East LSAs validity of plan is subject to the guidelines/instructions issued by Govt. of India/Regulatory Authority from time to time.
- The above plan is to be offered through BSNL CSC only.
- No concession in call charges from Landline/GSM/CDMA number to the "Parivar Plan" mobile number will be allowed.
