Sub: Revision in tariff of RCV/STV applicable to prepaid CDMA services -reg.

Kindly refer to this office order No.24-02/2009-R&C dated 28.04.2009, order No. 24-08/2009-R&C dated 29.10.2010 and subsequent orders issued from time to time on the subject mentioned above. Now it has been decided by the Competent Authority to rationalize the RCV/STV applicable to CDMA prepaid service as under:-

- To withdraw STV Masti-1 & 2 with MRP Rs.98 and Rs.54.
- To withdraw CDMA PCO/VPTs with MRP Rs.5800 and Rs.5670.
- To introduce the following new EVDO Data STVs to be available through C-top-up.

Note: When the customer is not using above Data STVs, normal plan data charge of Rs.0.05/100KB (Peak Hours) and Rs.0.025/100KB (Off-peak Hours) will be applicable.

- All other terms and conditions will remain same.
- The above tariff will be implemented with effect from **17.08.2011**.
 - This may be brought to the notice of all concerned for taking necessary action in this regard.
