Sub: New tariffs under CDMA services –reg.

It has been decided by competent authority to introduce the following tariffs under prepaid CDMA mobile services:-

i) **Friends and Family plan** in which the customer can talk to 5 F&F number at lower tariff than the normal tariff with some monthly subscription charges with the following terms and conditions:-

Upto Rs.49*	Rs.2	Card Value - processing fee
From Rs.50 to Rs.499	Nil	Equal to Card Value
Rs.500 and above	Nil	Card Value+ Bonus @ 10% of card value

*The card denomination is exclusive of Service Tax.
