Vehicle ^{2,3,4}	1 vehicle in each SSA headed by executive upto GM 2 vehicles in each SSA headed by PGM	AO sales / Franchisee Managers	Delivery of material to Franchisee doorstep, by Franchisee Manager and / or AO Sales

Notes to above table:

1. The admissible limits may be decided by the Circle and informed to the SSAs.
2. Vehicles may be diverted out of the sanctioned vehicles of the concerned Circle / SSA.
3. Vehicles are to be provided for delivery of inventory at the doorstep of the Franchisees, till such time delivery mechanism via courier is not institutionalized.
4. In case the vehicles mentioned above prove to be inadequate, use of transport on need basis may be reimbursed as per approval rate in SSA.
