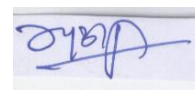

- Charges are exclusive of Taxes. Taxes as applicable shall be extra.
 - Security Deposit at applicable rate for ISD has to be taken.
 - Free MCUs shall not be adjusted against ISD usage.
 - *Fixed monthly charges are to be paid by ITD centrally at NTR, Delhi in lump-sum in two installments i.e. by 25th January and 25th July each financial year as per letter No. FTS (R) -837246/2010-Com (Coord.) dated 26th August, 2010 from CIT (Coord & System) Central Board of Direct Taxes, Department of Revenue, Ministry of Finance.
 - The monthly bills comprising of the charges for the services used beyond the allowed limit and / or for any additional services subscribed by the customer will be issued and sent to each customer by the concerned SSA of the Circle and recovery of the dues thereof will be pursued as usual. In case no payment is received, the service will be disconnected for the said number but it will not have any effect on the lump sum payment to be received from the ITD.
 - The detailed commercial guidelines and accounting procedure shall be issued separately by the EB and CA branch of Corporate Office respectively.
2. This Circular is issued based on the MOU dated 09.03.2011 signed between BSNL, MTNL and Income Tax Department dealt in EB Cell File No. 3-32/2009/EB-I. 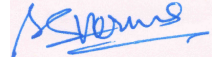
