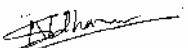
Circular T&C-CM No. 06/14-15

Sub: Clarification regarding rationalization of the Roam free plan of Rs. 199/91 (NE, Assam), RTP Plan 405 and RTP-FR Plan 705-reg.

Kindly refer to this office order of even no. dated 21.04.2014 under which GSM Prepaid tariff for Roaming Plans were rationalized. Based on queries raised by field units/INs, the following clarifications are issued:-

S.No.	Queries	Clarifications
1	Whether the mentioned freebies are to be allowed in both Home LSA and Roaming area?	• Yes, the freebies mentioned for RTP plan Rs.45 and RTP-FR plan Rs.199 will be applicable in Home LSA and Roaming area both.
2	Whether Free incoming is applicable for the BSNL & MTNL areas?	• The free incoming call is applicable both in BSNL & MTNL roaming areas.
3.	For RTP plan (with plan voucher 45), the incoming call charges while roaming is mentioned as 1.25paisa/sec. It is not possible in NSN IN to have 3rd digit precision.	• In view of technical non-feasibility of NSN INs, the incoming call charges while in roaming for RTP plan Rs.45 is modified as " <u>1.2paisa/sec</u> " from existing 1.25paisa/sec for NSN INs.

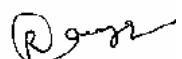
2. The above tariff will be implemented with immediate effect. Customers may be informed about revision of plan and suitably educated about the revision in tariff.
3. This may be brought to the notice of all concerned for taking necessary action in this regard.
4. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
