Sub: Revision of GPRS/EDGE tariff applicable to 2G Data Card and Voice plans- reg.

Kindly refer to this office order of even No. dated 23.08.2010, 25.05.2011 and orders issued from time to time vide which GPRS/EDGE tariff was intimated. Now, it has been decided by competent authority to revise the free data usage under GPRS/EDGE tariff plans under 2G postpaid and prepaid mobile services with the following terms and conditions:-

a) Revised free data usage under 2G postpaid data tariff plans:-

FMC of plan in Rs./Month*	Revised free data usage	
	Day/Any time usage	Night Usage
49	500 MB	Nil
89	2GB	Nil

*Service tax as applicable extra.

b) Revised free data usage under 2G prepaid data recharge vouchers:-

MRP of RCV in Rs. /30 days^	Revised free data usage		Validity in days
	Day/Any time usage	Night Usage	
54	500 MB	Nil	30 days
98	2 GB	Nil	30 days

^ MRP of RCV is inclusive of Service Tax @10.30%. Circles can suitably adjust the MRP in the price band upto Rs.3 (+/-) of above price considering the local market condition and technical feasibility.

c) All other terms and conditions will remain same

2. The revised tariff will be implemented with effect from **20.01.2012**. The implementation of the revised tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order issued by TRAI.

3. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response.
