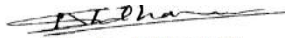
Sub: Introduction of New STVs under prepaid mobile services- reg.

It has been decided by the competent authority to introduce a new STV-29 "Weekly Dhamaka" with feature of free PRBT and unlimited song change and STV-9 under prepaid mobile services as under:

Note:

- Circles have to implement these STVs at Denomination of Rs.29 & Rs.9 only. If any other STV is working at denomination of Rs.29 & Rs.9, then that voucher can be shifted on next vacant denomination in both sides.
 - Moreover, physical voucher may be rolled out for these STVs by circles, if required.
- The above tariff to be implemented w.e.f. 06.08.2018.
 - The implementation of the tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order and orders/guidelines/clarifications issued by TRAI from time to time. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI and TRAI regulations contained in Ir. No. 5-5/2008/regl Dated 16.06.2008 issued from regulation cell BSNL CO.
 - Circles shall report to TRAI with full details of the tariffs offered without reference to any other circular as also detailed vide this office letter no. 11-11/2012-T&C-CM dated 03.02.2017 uploaded on intranet on 06.02.2017. Circles shall report to TRAI with full details of the tariffs offered with date of implementation of the tariff in reporting circle without reference to any other circular. TRAI has directed to ensure that the Reporting shall also contain Name, Designation and contact number of the authorized reporting officer/signatory for future reference. However, the circles should not endorse/send this circular for tariff reporting purpose and the content of the tariff should only be reported for tariff reporting.**
 - This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
 - This circular is issued based on the approval of ECT vide Approval No.3559 & 3548 dated 01.08.2018 in P&P-CM cell file No.3-38/ECT/2018/P&P-CM (Pt. III).
