Circular T&C-CM No. 07/15-16

Sub: Rationalization of national roaming tariff under prepaid and postpaid mobile services -reg.

Kindly refer to this office order of even no. 30.04.2015 and orders/clarifications issued from time to time regarding rationalization of tariff. Now it has been decided by the Competent Authority to **offer free incoming voice calls to BSNL mobile subscribers while in national roaming, as detailed below:**

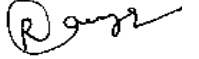
2. BSNL Mobile Subscribers will be provided **free incoming voice call facility while in national roaming** initially for one year on Pan India basis.
3. Free incoming voice calls while in national roaming will be implemented by creating STV/add-on of Rs. 101 (+/-3) under prepaid and postpaid mobile services. STVs/Add-on plans will be given notionally to all the BSNL mobile subscribers free of cost initially for a period of one year as a goodwill gesture.
4. Nodal Centers shall implement the above tariff and inform the subscribers through SMS/IVRS etc. that BSNL is offering free incoming voice facility while in national roaming for one year on pan India basis without any additional charge for the same.
5. Existing Roaming STVs viz. Rs. 5 (validity 1 day), Rs. 33 (validity 7 days), Rs. 69 (validity 30 days) and Rs. 90 (validity 90 days) under prepaid mobile services and Add-on plan with FMC of Rs. 61 under postpaid mobile services are **withdrawn**.
6. All other terms and conditions will remain the same.
7. The above tariff will be applicable **with effect from 15.06.2015**. The implementation of the revised tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order issued by TRAI. Customers may be informed about the said revision and suitably educated about the revision in tariff.
8. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above facility to the customers.
9. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
10. This circular is issued based on the approval in P&P-CM cell file No.3-72/2012/P&P-CM.
