Sub: Rationalization of tariff under prepaid mobile services-reg.

Kindly refer to this office letter of even no. dated 11.01.2016 and subsequent orders issued from time to time with regard to tariff under prepaid mobile services. Now It has been decided by competent authority to rationalize below voice STVs for "Per Second" and "Per Minute" Plans as under:-

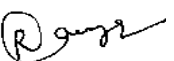
Sl. No	MRP of STVs (in Rs. inclusive of Service Tax)	Existing STV details	Validity in days	Revised Validity in days
1	88	For Per Minute plan: (a) 10paise/min for On-net voice calls (Local/STD), (b) 30paise/min for Off-net voice calls (Local/STD);	60	48
2	42(+2/-1)	For Per Second plan: (a) 1paise/3sec for On-net voice calls (Local/STD) (b) 2paise/3 sec for Off-net Voice calls (Local/STD)	21	No change
Note: These STVs are applicable to "Per second" and "Per minute" plans only.				

- All the other terms and conditions will remain same.
- The above tariff will be applicable with effect from 15.03.2016 on Pan India basis.** The implementation of the tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order and orders/guidelines/clarifications issued by TRAI from time to time.
- This may be brought to the notice of all concerned for taking necessary action in this Regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
- Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
- This circular is issued based on the approval of ECT vide Approval No.2218 dated 02.03.2016 in P&P-CMcell file No.3-38/ECT/2015/P&P-CM(Pt.I).
