Sub: Rationalization of tariff under prepaid mobile services-reg.

Kindly refer to this office letter of even no. dated 21.01.2015 and subsequent orders issued from time to time with regard to tariff under prepaid mobile services. Now It has been decided by competent authority to introduce new voice STVs for "Per Second" and "Per Minute" Plans as under:-

S.No.	MRP of STV (in Rs. Inclusive of Service Tax)	STV details	Validity (in Days)
1	88	all voice call (Local/STD/On-net/Off-net) in home LSA @50paise/min or 0.8paise/second	90
2	54(For all Zones Except SZ); 51 (for SZ only)	all voice call (Local/STD/On-net/Off-net) in home LSA @50paise/min or 0.8paise/second	45

Notes:-

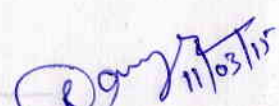
- (i) These STVs are applicable to "Per second" and "Per minute" plan only.
- (ii) If denomination is not vacant, the denomination can be chosen in the range of +/- Rs.1.
2. All the other terms and conditions will remain same.
3. **The above tariff will be applicable with effect from 16.03.2015 on regular basis.** The implementation of the tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order and orders/guidelines/clarifications issued by TRAI from time to time.
4. This may be brought to the notice of all concerned for taking necessary action in this Regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
5. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
6. This circular is issued based on the approval of ECT vide Approval No.1769 dated 05.03.2015 in P&P-CM cell file No.3-38/ECT/2015/P&P-CM(PT.I).
