Tariff for providing VPN services over Broadband has already been issued vide this office letter of even no. dated 3.6.14. Now, following tariff has been approved by competent authority for VPNo3G services:

Terms and Conditions:

1. Static IP charges of Rs. 1500 per static IP per annum shall be extra.
2. The tariff is for VPNo3G services only. Any other software/hardware charges shall be extra.
3. No discount to be offered on the above tariff as E-Governance rate of VPNoBB as reference has been taken.
4. The present tariff is applicable for one year only and circles shall be advised by PP-CM cell not to have any agreement on these tariffs for more than one year. After one year service and tariff shall be reviewed by PP-CM Cell.
5. Minimum period of hiring for VPNo3G services will be one year.
6. The VPNo3G services will be provided as a separate service and not as an "ADD-ON" service. However, it would be provided only with BSNL mobile connections.
7. The above mentioned tariff is not applicable in roaming MTNL area in view of ICR of data charges.
8. The tariff will be applicable from the date of issue of this circular.
