Subject: Signing of central MOU with Kendriya Vidyalaya Sangathan (KVS) and subsequent allotment of External Projects at various locations reg.

Ref: Copy of Central MOU received from CE(C) EP, ND vide letter no. 30.12/2011/CE(C)-EP/782 dated 13.12.2012.

It's my pleasure to inform you that BSNL has signed a central MOU with KVS for PMC Services @ 7.0% for various works for KVS with approval of the Director (EB), BSNL. As per the central MOU, CE(C) EP, New Delhi shall be the Co-ordinating Officer for BSNL at headquarter level for co-ordination and monitoring for KVS works.

This MOU is having certain special conditions such as liability for delay @ Rs. 5000/- per day on account of delay on the part of PMC and its assigned contractors, no escalation provisions for materials other than cement & steel and litigation liability of BSNL, if any, with the assigned contractor. In view of these special conditions a pragmatic approach is required to mitigate any Financial impact to BSNL by proactive action such as timely planning and execution of above project with proper co-ordination amongst all the stake holders.

Recently KVS has allotted following works to BSNL

1. Construction of School Building, Staff Quarters, Boundary Wall etc for Kendriya Vidyalaya, Sahebganj, Jharkhand in the plot area of 7.2 Acres allotted to them.
2. Construction of School Building, Staff Quarters, Boundary Wall etc for Kendriya Vidyalaya, CRPF Peringome, Kannur, Kerala in the plot area of 7.5 Acres allotted to them.

These are the first pilot projects assigned to BSNL in continuation to central MOU cited above. The CE(C) Jharkhand and CE(C), Kerala shall be the Nodal Officer for the above pilot project respectively.

It is requested that all stakeholders of this pilot project should complete their respective role with utmost sincerity, co-ordination and dedication so that the pilot project is successful in terms of Quality, Service & Time and generate goodwill to BSNL and further flow of External Works from the client i. e. KVS.

In view of above, it is requested to bestow your personnel attention and issue suitable directions to your respective Units at Zonal level for the above pilot project to co-ordinate and co-operate for successful completion of the project and thereby contribute to the precious revenue for BSNL.
