ORDER

Subject: Regularisation of services of STS Ad-hoc of Telecom Finance / Promotion to the grade of STS (CAO/AGM) on regular basis - regarding.

Approval of the Competent Authority is hereby conveyed for post based promotion of following executives of Telecom Finance in the grade of Senior Time Scale (Ad-hoc) to the grade of STS (CAO/AGM) on regular basis in the IDA pay scale of Rs 29,100-54,500, with effect from the date, when their juniors have taken over the charge of the post of CAO on regular basis in their respective circle, as per promotion order issued vide this office order No 2-1/2013 SEA BSNL dated 30-10-2014 and even No dated 26-11-2014. However, BSNL CO retains its powers to transfer them out of their circles/units, in the interest of Company.

Before implementation of these orders, the Circle(s) must ensure that Presidential orders for absorption of the executive in BSNL has been issued and executive to be promoted is working in the grade of STS on ad-hoc basis in the circle. Any other discrepancy, viz name etc of the executive shown in the order varies may be brought to the notice of BSNL CO with supporting documents for rectification of records. **Any request for declination of promotion / modification of place of posting on promotion will not be entertained at present by the management due to administrative exigencies.**

3 The promotion of the above executives is further subject to the condition that no disciplinary / vigilance case is pending against the executive. In case any disciplinary / vigilance case of the type referred to in D.O. P&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 is pending against the executive or some punishment like stoppage of increment etc., he should not be promoted and the matter should be reported to SEA and Vigilance Branch of Corporate Office immediately.

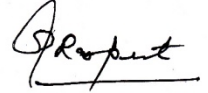
