**Sub: Recognition of majority representative Association of serving Executive employees in BSNL - Holding of 1<sup>st</sup> membership verification - extension of last date for submission of applications regarding**

In response to this office notice of even number dated 25<sup>th</sup> May, 2016, requests for relaxation of eligibility condition that "the Associations which are registered under the Societies Act or the Trade Union Act for a minimum period of one year as on date" have been received from few of the Associations for participation in the membership verification. The competent authority has acceded to the above-said request. 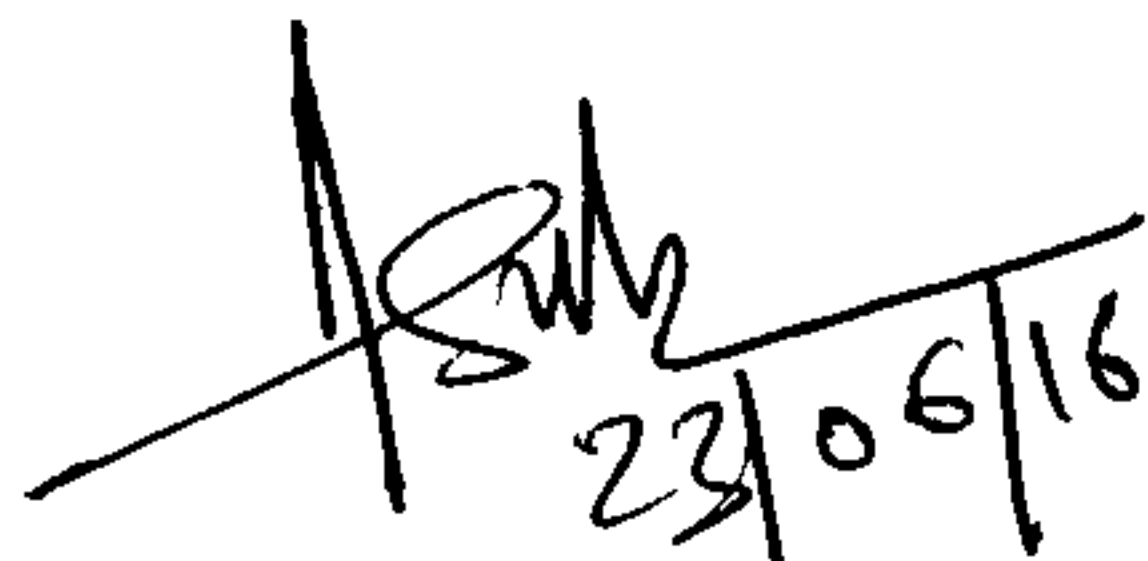
