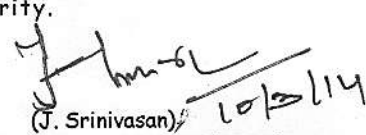
## ORDER

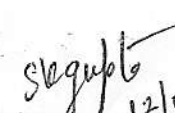
