Sub: Medical facility to government employees on deemed deputation.

Director (Estt.), Department of Telecommunications vide letter No. F.No. 4-12(20)/2009-PAT dated 6<sup>th</sup> May 2011 has informed that DGHS has clarified that as per existing CGHS policy, the P&T pensioners, who were not holding CGHS card at the time of retirement are not entitled for CGHS benefits. Therefore he has requested that the Government employees working on deemed deputation may be permitted to revert back to CGHS medical facility at any time during their posting in BSNL/MTNL or at least three months before their retirement, if they so desire, in order to enable them to hold CGHS card at the time of their retirement. Further, where the officer opts for CGHS facility, it may be ensured that treatment/ reimbursement for indoor/ outdoor treatment, as available under CGHS scheme is fully extended to them.

Government employees working in BSNL on deemed deputation retiring from BSNL unabsorbed are requested to take note of the above provisions.

Subject: Medical facility to government employees on deemed deputation

Sir,

The government employees working in BSNL/MTNL are being extended Medical Facility by these organizations in lieu of CGHS facility. However, these organizations are not extending medical facility to such officers after their retirement. Due to this reason, the Government employees retiring from deemed deputation in BSNL/ MTNL are left without any medical facility after their retirement. This has resulted into several court cases also.

2. The case of an officer, retired from deemed deputation from MTNL was referred to DGHS requesting them to extend CGHS facility to the pensioner after making required payment as per rules applicable to pensioner beneficiary. DGHS, vide their letter Z.15025/25/2009-CGHS.III dated 22.3.11 has clarified that as per existing CGHS policy, the P&T pensioners, who were not holding CGHS card at the time of retirement are not entitled for CGHS benefits.

3. In view of above, it is requested that the Government employees working on deemed deputation may be permitted to revert back to CGHS medical facility at any time during their posting in BSNL/ MTNL, or at least three months before their retirement, if they so desire, in order to enable them to hold CGHS card at the time of their retirement. Further, where the officer opts for CGHS facility, it may be ensured that treatment/ reimbursement for indoor/ outdoor treatment, as available under CGHS scheme is fully extended to him.

4. This issues with the approval of the competent authority.
