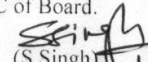

Subject:- Rationalization of number of landline & Broadband service connections working in the offices - instruction regarding .

In view of reducing IUC expenditure from service connections working in BSNL offices, the **Management Committee of the Board** has decided to rationalize number of landline & Broadband service connections working in the offices. Accordingly following instructions are hereby issued :

1. The number of Service landline connections working in offices of a circle shall be restricted to maximum 1% of total billed wired line connections in that Circle as on 01.01.2014 as per annexure-I. Circles in which service connections in offices are already less than 1% of total billed wired line connections in that Circle, there shall not be any increase in service landline connections in the offices.
2. The number of Service Broadband connections working in the offices of a circle shall be restricted to maximum 0.25% of total Broadband working connection as on 01.01.2014 as per annexure-II. Circles in which service BB connections in offices are already less than 0.25% of total billed Broadband connections in that circle; there shall not be any increase in service broadband connections in the offices.
3. Accordingly Circle shall conduct an immediate review of landline service connections & Broadband service connections working in the BSNL offices and close the extra service connections to bring landline service connections within specified limit.
- 3.1 However, CGMs of Circle in the exigency of the services **are authorized** to sanction wired line connection in offices beyond 1% and Broadband connection in offices beyond 0.25% also on the basis of requirement and justification. In such cases fresh sanction from CGM shall be required.
4. Further, CGMs shall ensure that name and designation of official are entered against each service connection for offices & residences in CDR system within one month from date of issue of this letter. For numbers working in offices/home of serving /retired employee of BSNL/MTNL/DOT where name & designation are not entered or are not available in CDR system after one month time, then CGM ITPC is requested to bar O/G calls from such numbers from CDR DC and after verification by circles and inputting name & designation and other details in CDR, O/G shall be restored.
5. Compliance report shall be submitted by Circles latest by 30.04.2014 for information of MC of Board.
