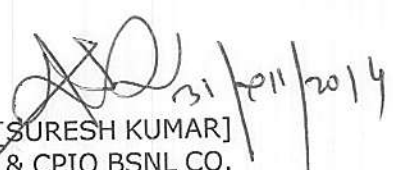
You are requested to make available the information asked for by the applicant to the undersigned immediately through hard copy as well as PGRMS Portal.

Your attention is drawn to the RTI Act 2005 and rules framed there under according to which the information cannot be denied except expressively exempted under the said act. Further, as per the said act the person causing delay in supply of information beyond 30 days is liable to penalty **@Rs 250/-** per day of delay subject to maximum of **Rs 25,000/-**

While furnishing the information to the undersigned the following should be clearly indicated:-

- i) Whether the information can be supplied to the applicant.
- ii) If not, the reasons thereof with specific reference to the exemption clause of RTI Act, 2005.

Section 5(4) & 5(5) of the RTI Act stipulate that the CPIO may seek the assistance of any other officer as he/she considers it necessary for the proper discharge of his/her duties. Any officer, whose assistance has been sought shall render all assistance to the CPIO seeking his/her assistance and for the purpose of any contravention of provisions of this Act, such other officer shall be treated as a CPIO.
