Subject: Shifting of Copper Cable on National Highways on behalf of NHAI - cost of shift thereof.

The National Highway Authority has undertaken widening of roads on larger scale on National Highways. While undertaking the expansion work of National Highway by NHAI, the Copper Cables are getting damaged time & again.

Therefore the copper cables needs to be restored time & again or to shift to, avoid breakdown of telecom services. To decide who will bear the cost of shift which is being done at the instance of Highway Authority. The case has been referred to committee of Secretaries. As the decision of committee of Secretaries may take sometime, thus the case was brought before Management Committee of the Board of the Directors, BSNL. The Management Committee of the Board of Directors of BSNL in the 75th meeting held on 2nd August 2003 approved the proposal for allowing field units to shift the copper cables due to widening of National Highways wherever necessary. It has also been approved that initially the shifting work be carried out at the cost of BSNL for which circles shall send details to National Highway Authority each time for claiming the reimbursement & keep all records relating there to for use. Material required for shifting work be arranged/procured by CGMs concerned after allotment by the Planning Branch of BSNL based on recommendations of MS Cell. However this will be applicable on case to case basis. The field officers shall have to give full justification, including exploring the possibility of opening RSUs/RLUS's before shifting the Copper Cables.
