**Sub: Huge discrepancy in the BSNL CO letter dated 20.01.2022 issued in respect of Look After arrangement for AGM(T) and DGM(T) Posts reg:**

**Respected Sir,**

We would like draw your kind attention that vide the letter under reference (1) above, BSNL Corporate Office issued the Revised Sanctioned Strength for Executives as: DGM(T): 1,116 posts and AGM(T) : 4,500 posts. Out of 1,116 DGM(T) posts, hardly 130 DGMs are working on Adhoc basis. So, the remaining vacancies in DGM cadre are 986 posts. Similarly, about 1,400 DEs are working in BSNL. So, the remaining vacancies in DE/AGM cadre are about 3,100 posts.

Surprisingly, vide the letter under reference(2) above, BSNL Corporate Office issued instructions to the Circles to restrict the number of DGM posts to 776 (instead of 986) and AGM posts to 2200 (instead of 3100), with huge cut in the already depleted strength after Restructuring. We are not concerned about LA arrangement as we are opposing it. Our concern is how the number of posts has come down drastically and how this figure has arrived at all. This has created confusion in the field units. It is another humiliation to the Executives who are waiting for years together for their legitimate DE/AGM(T) and DGM Regular Promotions.

In view of the above, we request your goodself to kindly intervene in this matter and re-examine the matter and issue necessary instructions by retaining all the posts in the Revised Sanctioned Strength of Executives as per the BSNL CO Letter No.4-02/2021-Restg dated 23-11-2021 and render justice
