## REMINDER

**Sub:-** Transparency is missing in the transfer orders issued so far as many requests are pending, favoritism and pick and choose method adopted in considering request transfer by Pers section. Non-Consideration of request transfers of Executives applied through OTP. OTP transfer was introduced for transparency in transfer and posting at BSNLCO. But on implementation, Pers section made it as the biggest failure by pick and choose method. Make thorough enquiry and fix the responsibility for restoring the credibility of BSNLCO:

Online Transfer Portal was implemented by BSNLCO to bring more and more transparency in processing the transfer requests of the Executives. However after observing the transfer orders issued by Pers Section during last three quarters, it is observed that transfer orders are issued at the whims and fancies of the few individuals in the Pers section, especially PGM(Pers). Transparency is totally missing as the concerned Executives are not aware why their application is not considered while others with same criterion were considered and got the transfer order. We earnestly request the Management to thoroughly verify the short comings in maintaining the Transparency in the Transfers orders issued and fix the responsibility for restoring the credibility of BSNLCO.

Once again it is requested to urgently review the whole matter in a transparent manner and issue the transfer orders at the earliest.


