## Sub: Modification of request transfers of SDEs from Hard Tenure Stations to choice stations/Circles- Reg.

## Ref: BSNLCO-PRII/19(11)/5/2021-PERS-II dated 25.06.2021

As per transfer policy followed by DoT and BSNL, on completion of Hard tenure posting, the officers will be offered the choice places. This is done even by displacing the long stay officers working in that station, if vacancy is not available. This is the healthy HR practice followed by DoT and BSNL for decades together to encourage the Officers to move to Hard Tenure stations.

However, following SDEs who have completed their hard tenure and requested to posting to their choice Circle were not considered and posted to STR. As per transfer policy, after completion of the Hard tenure, all the officers requested to respective territorial Circles and not requested for STR. The posting is to be made as per the request of the officer. All the SDEs are sufficiently seniors and will get LA AGM/ DE in the territorial Circle as already their juniors are working on LA in the Circle. If posted to STR, because of limited posts, they will not get LA in their choice place.

Kindly do the justice to the SDEs completing tenure in Hard tenure Stations of A&N, NE1 etc. As BSNLCO has already taken decision to merge STP and STR, the experienced officers of STP Circle who are underutilized can be posted for taking care of STR.
