Induction from Finance and Civil/Electrical streams in the CHQ body will inject confidence among the Executives in those wings.

Veteran leaders Late Com W. Seshagiri Rao, Com G. L. Jogi and Com S L Reddy were source of inspiration for me. CHQ President and my entire colleague CHQ Office Bearers were extremely enthusiastic and supported in all CHQ activities. Always, my real strength was the Circle Secretaries. There are so many other senior leaders, who supported me and guided me to address some of the issues in the best interest of the cadre. Thanks to all of them.

Comrades, my journey with this mighty Association stated in 1995 as a Branch Secretary of Kasargod in North Kerala for 3 terms, Kannur SSA Secretary for 2 terms and then as Kerala Circle Secretary for 3 terms before moving to Delhi as Asst General Secretary in 2009.

Becoming GS at young age gave me the opportunity to work for the Executives with long term planning, strategy and vision, instead of short term goals. The major achievement is the BSNL Revival package fully funded by the Govt. Again, 2nd Revival package is on the pipeline with: i) liberalized 5 MHz 2G spectrum, ii) CAPEX funding for 4G equipments, Transmission Network/ and CFA, iii) Compensation for Rural services, iv) debt restructuring etc.

Some important cadre issues have been made over to me by my predecessors, Late Com W Seshagiri Rao and Com G L Jogi. Time Bound Promotion Policy, Standard Pay scales of E2 and E3 and Superannuation Benefit for BSNL Direct rects are the key ones. We taken it forward and reached level of settlement by the approval of BSNL Board. It gives me immense pleasure when more than 26,500 Executives got promotion during these years. Group Term Insurance was a great relief to many families during the Covid pandemic.

I am sure that through focused and united efforts, the new CHQ Body will bring the pending issues to the logical conclusion in the near future; thereby the aspirations of our young generation will be taken care. The Indefinite Hunger Fast for more than 45 days, which is continuing as per the historic decision of the AIC, shows the commitment of our Association in resolving the most important HR issues of BSNL Executives, the Pay Scales and Promotions. Terms and conditions for absorption will provide us the legal backing for these two issues. Remember, for the settlement of issues, struggles should lead to political intervention, not the other way, this is the lesson we learned from last 3 decades since 1986. I wish, the new SNEA CHQ body live upto the expectations of all the Executives, unite them all and contribute immensely to BSNL. I take this opportunity to extend my full support to the new CHQ OBs for all their sincere efforts to settle the issues of E2 and E3 pay scales, Time Bound Promotions upto Selection Grade DGM, 3rd PRC, full SAB contribution, Pay loss etc.
