Actual rate effective from 01-07-2021 for 2017 scale is 24.6%, for 2007 scale it is 173.6% and 361.9% respectively.</p> <p>Adding to the injury of DA freeze for the past, unfreezing circular was another assault on the executives by paying two different percentage of DA for workers and executives. Despite our request to correct this discrepancy, DPE is keeping a silence over the referred discrimination, which has lead to widespread agony amongst the officers of CPSEs and so National General Council meeting of NCOA held at Delhi on 12-09-2021 has decided to have the following protest actions.</p> <ol style="list-style-type: none">1. Wearing Black Badge/Mask on 07-10-20212.
