Respected Sir,

With reference to above subject and letter dated 25/07/2025, by submitting detailed reports, we have drawn your kind attention towards the untenable and deteriorating situation under the current CGM, Shri S. Parthiban, heading Tamil Nadu and Chennai Circles, Despite repeated submissions and appeals from all Unions and Associations regarding the untenable situation in Tamil Nadu and Chennai TD Circles, there has been no corrective action from the management that to be after your kind intervention and assurances during your Chennai visit on 18/07/2025 and delegation of GS of All Unions and Associations. .

Instead of following your directions to resolve unrest and maintain harmony, the CGM Shri Partibhan has intensified his vindictive approach by issuing charge sheets, memos, and compelling General Managers to serve punishment orders beyond their authority. This has created an explosive situation in both Circles and has deeply demoralized the workforce. Such type of adamancy and authoritarian approach even after directions of CMD BSNL is not going down well with the rank and file of employees across the nation.

Seeing no hope of resolution either from BSNL Corporate or from Chennai administration, the unions and associations of BSNL TN & CHTD Circles have served the protest notice for a day long dharana at office of CGM TN Circle as per reference 5 above.

This agitational programme will be supported with lunch hour demonstration all Over India at BSNL Corporate Office, at Circles and OAs/BAs i.e. across the country in solidarity with the victimized office bearers of associations with:

Demands:

- 1. Immediately shift Shri S. Parthiban from the posts of CGM TN & CHTD and finally repatriate to DoT.
- 2. Withdraw all vindictive actions initiated against leaders and employees of CHTD

Program: Lunch hour demonstration on 6th October 2025 between 1.30 to 2 PM at A/BA/Circle and Corporate Headquarters.

Failure to act immediately will send a wrong message to the workforce that management is protecting an officer whose conduct has failed on every front of BSNL's requirements.

This programme will be held in solidarity with the members and leaders of Tamil Nadu and Chennai TD Circles and as a mark of protest against the autocratic and revengeful actions of the CGM.

We sincerely hope that your office will intervene before the situation escalates further and take immediate corrective measures to restore peace and industrial harmony.
