**Sub: Launching of BSNL Inventory Tracking System (BITS) - Reg**

As part of the initiatives by Dir(CFA), ITPC Pune has launched an application for QR code based tracking of the material movement in ERP. The salient feature of the portal are

- Tracking of the material movement in ERP using QR code
- Email and SMS alerts for stock transfer through POs
- Management reports for material movement status.
- Dashboard to view the PO/OBD/Good Receipt details
- Facility to carry out Goods Receipt activity through portal or mobile app.

The stock transfer activities through POs (ZGTO & ZSTI) are covered in the initial phase.

The solution consists of a web portal (url : <https://bits.bsnl.co.in>) for recipient, supplying plant users and Circle co-coordinators and mobile app for the BSNL representative for physical acceptance of goods using QR code.

The training on this application will be shortly conducted by Zonal Data Centers.

**Important:** Since the SMS and Email alerts are sent to the Store-in-Charges, based on the Role mapping done in ERP, all field units are requested to keep the role mapping data up to date by removing any old roles from the ERP system. **BITS system is to be implemented in above mentioned circle and circle head should ensure its timely implementation.**
