Claims for Telecom services provided to DOT officers and officials (both working and retired) up to 31.03.2020 have been raised in FY 2021-22. Summary data provided by ITPC & details are enclosed. Directions were issued for getting the claims verified by CCAs as payment of Rs. 107 Cr. out of claim of Rs. 233 Cr. was received. Balance of 20% of claims was to be raised post verification of claims by CCA offices, but till date the work has not been accomplished.

DoT has issued letter dated 01.04.2025 (copy enclosed) to CGCA with copy to CMD, BSNL to provide the necessary details to field units to facilitate the verification of submitted claims in a time bound manner, so that work can be completed by 30.04.2025.
